

# Purushottam Bhagchandka Academic School

### Dear Parents / Guardian,

We thank you for being an integral part of the school in its journey of development in these initial years. We also thank the large majority of guardians who have cleared their fees well within due dates, which has helped us to meet various financial commitments on account of operational cost. However, the school requires the cooperation of <u>all parents</u> to meet its financial obligations. Despite its limited resources but with the help of all parents, the school will continue its scholarships awarded to meritorious students in the current academic year as well.

All assignments for all classes and subjects are being conducted regularly since April. Regular exams and PTM are also being conducted online during this period. The School has been giving counselling services to students and parents online. All classes on Art Craft, Music, Dance, Physical Education, Yoga, Robotics are being offered as regular classes as per its diary schedule which are being availed of by all the students. The school has also hosted interhouse competition and interschool competition. Besides, the school is conducting all activities including Science Labs, Nature Club, Science Club, Maths Club, albeit online, which has been immensely appreciated by parents. The school, despite a lower fee structure, has continued to provide such facilities and/or services to the students, which are essential part of the curriculum and holistic development.

The existing fee structure for academic session 2020-21 is same as that of academic year 2019-20. The school, as required by the order dated October 13, 2020 of the Division Bench of the Hon'ble High Court at Calcutta in WPA No. 5890 of 2020 read with the order dated October 28, 2020 of the Hon'ble Supreme Court, is providing further reduction, until further orders of the Court. We, however, earnestly request parents to continue paying the existing fees (i.e. not availing the reduction) if their financial situation may support.

## Notes:

- 1. Library fees have been completely waived off.
- 2. Bus Fees has been completely waived off.
- 3. All session / periodic fees will be reduced by 20% to the following: Pre-nursery (Rs. 8,000); Nursery-KG (Rs. 10,000); Class I –XII (Rs. 10,400)
- 4. Computer Tuition Fees will be reduced by 20% and payable only by applicable classes / taken as elective. This is essential part of curriculum and is taught online as a regular academic class which the students are attending.
- 5. Essential Charges include essential costs for facilities and ECA classes which continue to be provided and being availed by students. These essential charges will be reduced by 20%.

### A Genuine Appeal to Parents to meet financial obligations of the School:

PBAS has created a world-class infrastructure for its students, which required substantial bank borrowing leading to significant monthly outflow of funds on account of interest and repayment which are yet to be discharged. The current situation has made it extremely difficult for the school to meet its obligations to the bank, teachers and maintaining the infrastructure. The school faces greater financial stress than most other institutions due to this situation. The school makes an earnest request to parents, in line of the observations made by the Hon'ble High Court, not to avail of the reduction in fees as mentioned above if their financial situation permits them to pay the existing fees without concession. These small steps from the parents will provide the much needed financial support to the School and enable the School to keep up its infrastructure and education standards without any interruption.

- 1. For guardians who do not wish to avail the Concession Fess: They can continue to pay the fees from the school online payment system. Such parents will also avail the Covid concession which the school already offered in July-Sep. We will be grateful to such parents.
- 2. For guardians who wish to avail the Concession Fees: Please state your intent to avail the Concession Fees by sending an e-mail at <a href="mailto:feewaiver@pbacademic.com">feewaiver@pbacademic.com</a> along with the name of the Student and UID number. You may request details of the amount payable by you up to November, 2020 as a return mail. The guardian may also visit the school office on the working days from 10.00 AM 3.00 PM for any clarification. All payment will need to be tendered at the School office by way of DD/NEFT within 30.11.2020. Such guardian shall also be informed about the procedure to adjust the extra amount paid for the year, including adjustment of all previous concessions given on account of the pandemic vide a later notification.

The above information and decision are subject to any further order/s that may be passed by the Hon'ble High Court and/or the Hon'ble Supreme Court of India, as the case may be.
